### 1. Welcome and introductions

### 3. Today's discussions

3.1 Melissa from Gorbals Ideas Fund popped in and gave a brief update on the results of the voting before Christmas.

3.2 Susan gave feedback from Head of Maintenance (Tracey) following the estate walkround. NGHA have cleared all the areas of concern which were pointed out and water-logged drains. We will remove bushes at the corner of each block and returf areas as we progress with the painting work. Tracey is still trying to confirm a time and date with Glasgow City Council for a meeting and once that is established she will contact residents to help identify the areas of unsafe paving/carpark areas to see if GCC can carry out remedial work.

The mossed area at the back of resident's property will be cleared again before spring. Residents agreed the area was looking a lot better, however there is a lot of litter. Tenant volunteered to do a litter pick of the area the next day.

3.3 Suzanne reported that a programme of works for the area was also being put in place. Suzanne will chase up the work to suppress the weeds.

3.4 Discussion about tenants not living in the property. Susan will check with Housing.

3.5 Drying area is full of old kitchens/beds and needs to be cleared. Suzanne will visit.

3.6 Discussion about housing allocations again. We are producing a factsheet with the main points of our allocation process to try to make it as clear as possible.

Anyone who would like to know more is welcome to come into the office to speak to a Housing Officer or Manager.

3.7 Individual issue with crack in living room. Suzanne will visit.

3.8 Resident commented that things were going well and issues being resolved. However, we acknowledged there are Council issues which we cannot sort where we need the help of both NGHA and residents to report these issues or to contact councillors.

3.9 Side window light is on permanently and is very bright. Could anything be done to dim this? Suzanne will investigate.

#### 4. Other business

4.1 Susan handed out community and tenant events. Follow up with computer class information.

4.2 Tenant conference is on 28<sup>th</sup> March. Tenants filled in their booking forms.

4.3 Susan talked about the close cleaning survey being carried out by the New Gorbals Scrutiny Group and tenants completed the forms.
