### Purpose

To clean and maintain the public conveniences on the Coastal area, carry out any other cleaning duties under the direction of the Litter Lead Hand and remove litter from beaches, grass areas, roads, paths etc. using the necessary tools and equipment.

Ensuring that the quality of litter cleaning is to the standard specified by FCCT.

Carrying out litter clearing following a programme of frequency as determined by the requirements of specific area's.

Emptying litter bins as specified in the appropriate route in Fife and advising any defects as soon as possible to the Lead Litter Pickers.

Cleaning and maintaining the public conveniences on the Coastal area to standards as determined by Fife Coast and Countryside Trust
